

**PEKER GAYRİMENKUL YATIRIM ORTAKLIĞI ANONİM ŞİRKETİ**  
**CLARIFICATION TEXT ON THE PROCESSING OF PERSONAL DATA**  
**IN TRANSACTIONS MADE THROUGH THE WEBSITE CONTACT**  
**FORM**

As a visitor of Peker Gayrimenkul Yatırım Ortaklığı Anonim Şirketi's ("Peker REIT") <https://www.pekergyo.com/iletisim> website, your personal data is collected, processed and transferred by Peker GYO as the data controller in accordance with the Personal Data Protection Law No. 6698 ("LPPD" or "Law"), under the conditions described in detail below. With this text, we hereby inform you about the processes of collecting, processing and transferring your personal data and your rights under the Law.

**1. Data Controller**

Peker GYO determines the purposes and means of processing your personal data by acting as the '*data controller*' defined in Article 3/1-(1) of the Law in the processing of your personal data.

Peker GYO, as the data controller, is obliged to establish and manage the data recording system and to take administrative and technical measures regarding data security. In this context, it may also process your data to third parties who have the qualification of '*data processor*' defined in Article 3/1-(1) of the Law.

**2. Processed Personal Data**

As a visitor filling out the contact form on Peker GYO's website <https://www.pekergyo.com/iletisim>, your personal data such as name-surname, e-mail, telephone number and the content of your message are processed.

**3. Methods and Purposes of Collecting Your Personal Data**

Your personal data is collected electronically by Peker GYO through automated means by filling out the form on the website <https://www.pekergyo.com/iletisim>.

**4. Processing of Your Personal Data, Legal Reasons and Purposes of Processing**

Your personal data collected by Peker GYO, although it may differ according to the content of your message, is processed in accordance with the principles set out in Article 4 of the Law in accordance with the principles set out in Article 4 of the Law, within the processing conditions set out in Article 5/II of the LPPD for the purposes of carrying out the necessary work by the business units to benefit the relevant persons from the products and services offered by Peker FYO, carrying out the relevant business processes and communicating with you about the subject you have applied.

In addition, we do not have absolute control over the information you share with this form. We recommend that you do not share your personal data and sensitive personal data that you do not want us to know with our Company.

**5. Persons to Whom Your Personal Data is Transferred and Purposes of Transfer**

Your personal data collected by Peker REIT may be transferred to legally authorised public institutions for the purposes described in this text within the scope of the data processing conditions regulated in Articles 5 and 6 of the Law within the framework of the personal data processing conditions and purposes specified in Article 8 of the Law.

## 6. Your Legal Rights

As the personal data subject, in accordance with Article 11 of the Law, by applying to Peker GYO as the data controller;

- Being acquainted whether your personal data is being processed,
- Requesting information if your personal data has been processed,
- Being acquainted the purpose of processing your personal data and whether they are used in accordance with their purpose,
- Being acquainted of the third parties to whom your personal data is transferred domestically or abroad,
- Requesting correction of your personal data in case of incomplete or incorrect processing and to request notification of the transaction made within this scope to third parties to whom personal data is transferred,
- Requesting the deletion or destruction of personal data within the framework of the conditions stipulated in Article 7 of the Law (the disappearance of the reasons requiring the processing of your personal data, although it has been processed in accordance with the provisions of the Law and other relevant laws) and to request notification of the transaction made within this scope to third parties to whom personal data is transferred,
- Objecting to the occurrence of a result to your detriment by analysing your processed data exclusively through automated systems,
- In case you suffer damage due to unlawful processing of your personal data, you have the right to demand compensation for the damage.

You can communicate these rights by filling out the "Application Form on the Processing of Personal Data of Data Subjects" at [www.pekergyo.com](http://www.pekergyo.com) and using the methods in this form. Your request will be finalised as soon as possible and in any case within thirty (30) days at the latest, free of charge as a rule, but exceptionally for a fee in the tariff determined by the Personal Data Protection Board if it requires an additional cost.
